# Meet Wyman White, 1st Sgt., U.S. Sharpshooters

Speaker: Stan Saperstein

This month's meeting will feature a first person impression of Wyman White, a sergeant with the U.S. Sharpshooters. Hear Stan Saperstein describe White's experiences with Company F of the 2nd U.S Sharpshooters from 1861 to 1865. This presentation is based upon Wyman White's diary entries, and Stan's new book, *Sharpshooters*.

Our speaker this month is Stan Saperstein. He received his BA from Rider College, and his MA in history from the College of New Jersey. A member of Camp Olden Civil War Round Table, Stan also serves on the Board of Directors of Swan Historical Foundation, and is Director of Preservation of the SUV Museum.

Mr. Saperstein is the author of numerous publications on the Revolution, Civil War, and period furniture making. He recently retired from employment with the State of New Jersey as a personnel manager.

Stan has been a re-enactor since 1974, portraying a colonial woodworker, Revolutionary War rifleman, and Civil War United States Sharpshooter. He has lectured extensively to various historical groups. You can check out his activities on the web at www.artisansofthevally.com.

#### PRESERVATION NEWS

Our preservation partner for 2003 - 2004 is the Gettysburg Battlefield Preservation Association. Founded in 1959, the GBPA was the first public/private partnership at Gettysburg. "Over the years, the GBPA played a continuous role in purchasing endangered battlefield land." Their successes include saving the Meals Farm, the Timbers Farm, the Wolf Farm, the Taney Farm, the Colgrove tract, the Willoughby Run tract, and the East Cavalry field tract.

Their current project, the one that our donation will assist, is the Lady Farm, scene of fighting along the Hanover Road on the second day. If we meet our usual \$1000 goal, we will save 1/4 acre of hallowed ground. And with \$224.26 to date, we are off to another strong start. Plans are also in preparation for a special spring tour of the Lady Farm for Library sponsors, another reason to support the effort. As always, thank you for your important role.

# Who Am I?

I was born in Williamson County, Tennessee on June 8, 1806. After graduating from the University of Nashville in 1827, I practiced law for some time in Columbia, Tennessee, with James Knox Polk (later President of the United States) as a partner.

An unsuccessful aspirant for the office of vice president in 1852 and 1856, I had been appointed in 1846 a brigadier general of volunteers by my former associate. Subsequently I was advanced by Polk to the grade of major general.

Twice wounded in the Mexico City campaign, I fell out with General Winfield Scott, but was sustained by the President on all occasions, who declared that I had been "greatly persecuted."

I was named senior major general of Tennessee's provisional army upon the secession of the state in 1861, and was appointed brigadier general in the Provisional Army of the Confederacy on July 9 of that year.

I was at the battle of Belmont, Missouri in November 1861, and was second in command to General John B. Floyd at Fort Donelson the following February.

During Grant's siege of Donelson, Floyd passed the command to me, and I in turn passed it to Simon B. Buckner. Floyd and myself made our escape before the surrender of the fort.

Subsequently relieved of duty, I held no important command thereafter. I was assigned to the volunteer and conscript bureau in Tennessee during the latter part of the war, and was commissary general of prisoners after the death of General J.H. Winder in February 1865.

I was forced into bankruptcy after the war, but practiced law in Memphis with former Governor Isham G. Harris as my partner.

I died near Helena, Arkansas on October 8, 1878, and am buried in Memphis. Who am I?
